## SECTION 4) FIRST-AID MEASURES

### Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing.

Get medical advice/attention if you feel unwell or are concerned.

### Skin Contact

### Suitable Extinguishing Media

## SECTION 7) HANDLING AND STORAGE

### Ventilation Requirements

Use only with adequate ventilation to control air contaminants to their exposure limits. The use of local ventilation is recommended to control emissions near the source.

### Storage Room Requirements

Keep container(s) tightly closed and properly labeled. Store in cool, dry, well-ventilated areas away from heat, direct sunlight, strong oxidizers and any incompatibilities. ## SECTION 8) EXPOSURE CONTROLS/PERSONAL PROTECTION

### Respiratory protection

If engineering controls do not maintain airborne concentrations to a level which is adequate to protect worker, a respiratory protection program that meets or is equivalent to OSHA 29 CFR 1910.134 and ANSI Z88.2 should be followed. Check with respiratory protective equipment suppliers.

### Eye protection
