## SECTION 4) FIRST-AID MEASURES

### Inhalation

Remove source of exposure or move person to fresh air and keep comfortable for breathing.

Get medical advice/attention if you feel unwell or are concerned.

### Skin Contact

## SECTION 5) FIRE-FIGHTING MEASURES

### Suitable Extinguishing Media

Dry chemical, foam, or carbon dioxide is recommended. Water spray is recommended to cool or protect exposed materials or structures. Carbon dioxide can displace oxygen. ### Precautions for Firefighters

Isolate immediate hazard area and keep unauthorized personnel out. Stop spill/release if it can be done safely. Move undamaged containers from immediate hazard area if it can be done safely. Water spray may be useful in minimizing or dispersing vapors and to protect personnel. Water may be ineffective but can be used to cool containers exposed to heat or flame. ## SECTION 7) HANDLING AND STORAGE

### Ventilation Requirements

Use only with adequate ventilation to control air contaminants to their exposure limits. The use of local ventilation is recommended to control emissions near the source.

### Storage Room Requirements

Keep container(s) tightly closed and properly labeled. Store in cool, dry, well-ventilated areas away from heat, direct sunlight, strong oxidizers and any incompatibilities. Store in approved containers and protect against physical damage. Keep containers securely sealed when not in use. Indoor storage should meet OSHA standards and appropriate fire codes. Containers that have been opened must be carefully resealed to prevent leakage. Empty containers retain residue and may be dangerous.

## SECTION 8) EXPOSURE CONTROLS/PERSONAL PROTECTION

### Respiratory protection

### Eye protection
